1. Name of the Society : JANHIT EDUCATION SOCIETY
VILL. & P.O. CHARKHI (BHIWANI)
 2. Location of Regd. office : THE Registered office of the Society
Will remain at VILL. & P.O. CHARKHI (BHIWANI)
 3. Area of the Operation : VILL. CHARKHI, Bhiwani-Haryana-India
 4. Aims and Objects :
 - (i) To open Nursery, Primary, Middle, High, Higher, Senior Second ary Schools And Degree Colleges, Sewing & Stichings Centres Computer Centres, Polytechnical Colleges, Different trades of Industrial Trainings, Nursery Training Center, Gurukul, Sports School, College, Academy and Hostel for boys and girls in rural and urban areas.
 - (ii) To Open Hospital, Orphanage, Temple or other institution for social service
 - (iii) Teaching of Modern arts and Science on up to date Lines in less Expenditure.
 - (iv) To cater the educational needs of the fast growing areas of Vill. Charkhi and nearby area of Bhiwani Distt. and Haryana State.
 - (v) Teaching of Ideology of great Indian Saints, Leader & educationists.
 - (vi) To cater pupil's mental, physical and moral growth through curricular and co-curricular activities and to inculcate national spirit in their minds.
 - (vii) To help the pupils, develop their better qualities and spirit of leadership
 - (viii) The inculcation of habits of living in accordance with the rich and real values of of tradition and culture.
 - (ix) To obtain money, loan, aid & grant from Bank/Banks, Financial Institutions, Firms or Companies for the aim and objects of the society in the lawful manner and to apply to deal with the same in such a manner as may be considered the most desirable for giving effect to such aims and objects.
 - (x) To do all such acts to promote study and research.
 - (xi) To do all such things as are identical and conducive for attainment of the above aims and objects or any of them.

5. CONDITIONS:

- (A) The income and property of the society shall be applied solely towards the promotion of the objects of the society as set forth in the memorandum of association and no portion thereof shall be paid or transferred directly or indirectly, to the members of the society.
- (b) No member of the Governing Body of the Society, shall be appointed to any salaried office of the society, no remuneration shall be given by the society to any member of the governing Body except repayment of out of pocket expenses and interest on money lent or rent for premises/demised to the society.
- (c) The society by its constitution is required to apply its profits, if any, or other income in promoting its objects.
- (d) If upon the winding up or dissolution of the society there remain after satisfaction of all debts and liabilities any property whatever, the same shall not be paid to be or distributed among the member of the society, but shall be given on transferred to some other institution having objects similar to the objects of the society to be determined by similar to the objects of the society at or before the time of dissolution.
- (e) The Society can not sell its property/properties what so ever in any members and under any circumstances.

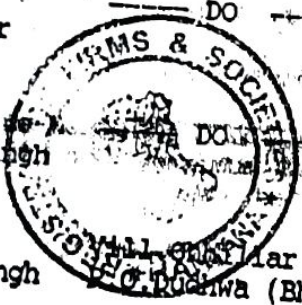
